# Trailblazer Award



## State Correctional Police Officer Lizette Anderson

Officer Lizette Anderson is a twenty-year veteran of law enforcement who proudly serves with the New Jersey State Department of Corrections.

Lizette was born on the island of Puerto Rico and in 1970 her mother moved her family from Santurce, Puerto Rico to Jersey City, New Jersey. During her adolescence Lizette enjoyed boxing and got into the ring a few times with gold glove champions. At the age of 18, she joined the United States Army. Lizette feels that the Army shaped her to become the woman she is today.

After her military service, Lizette went back to school and obtained a bachelor's degree in Psychology from Rutgers University and a master's degree in Nursing from Saint Peter's University. However, Lizette had always wanted to become a law enforcement officer, so she decided to pursue that career path. In the 1980s her dream job became a reality when Lizette became a police officer with the East Orange Police Department. Unfortunately, after a few years, she and several other officers were laid off.

Several months later, Lizette was hired as an Officer with the State Department of Corrections. After completing her time as a rookie, she envisioned herself doing different tasks, and through hard work, she was able to accomplish many of her career goals; one being part of a Special Operation Group, a Central Transportation Unit (U.S. Marshal), and a member of the DOD for the State of New Jersey.

Lizette was taught that survival is the name of the game and to learn from the best. She has been fortunate to have met Sergeants and Lieutenants that believed in her with the utmost of confidence.

Officer Lizette Anderson said the essential thing in her life is her family.



### **POLICE OFFICERS OF THE YEAR AWARDS**

On March 27, 2018, the Street Crimes Units of the Jersey City Police Department executed a 'No Knock' Search Warrant for an apartment on Glenwood Avenue in Jersey City, New Jersey based on information from a reliable source that heavily-armed occupants were producing and selling a large amount of narcotics.

Upon entry into the apartment, the Street Crimes Units were met with multiple individuals who were believed to be armed with handguns, with one running out the apartment window and one towards the bathroom in an attempt to destroy evidence down the toilet. All the seven occupants were secured, placed under arrest and charged accordingly.

The Street Crimes Units recovered \$30,000 in value of narcotics; 5 handguns; one double-barreled shotgun; hundreds of rounds of ammunition and thousands of dollars of suspected narcotics proceeds.

We commend these Police Officers of the Jersey City Police Department Street Crimes Units for their bravery and disregard of safety in successfully taking down a large drug operation and armed individuals that were directly across the street from St. Peter's College.

In 2017, he deployed with a Joint Special Operations Task Force, in support of Overseas Contingency Operations, where he served as the Maritime Security Department Head.

In January of 2019, he reported to Commander, Submarine Group 10, Force Protection Detachment 1, where he is currently serving as the Senior Enlisted Leader.

Senior Chief Gonzalez's academic achievements include a Bachelor of Science Degree in Police Studies from John Jay College of Criminal Justice, and an Associate of Science Degree in Criminal Justice from Essex County College. He is also a graduate of the 219<sup>th</sup> Class of the U.S. Naval War College, Senior Enlisted Academy.

Senior Chief Gonzalez's personal awards include the Joint Service Commendation Medal, Navy and Marine Corps Commendation Medal (three awards), Navy and Marine Corps Achievement Medal (two awards) and the Enlisted Expeditionary Warfare Specialist pin.

Senior Chief Gonzalez is married to the former Jenny Reyes of Moncion, Dominican Republic. They have two children, Jennise Noemi (14), and Nathan Jesus (8). He has been a Police Officer for 17 years and is currently serving as a homicide Detective for the Hudson County Prosecutor's Office.
